Statement of Risk & Waiver of Liability

Our Club is organized to promote and teach fly fishing in its many forms, and to assist in the development and maintenance of the fisheries in the area. We hold regular meetings and organize regular outings to local fishing areas and, in coordination with the Arizona Game and Fish Department; we schedule periodic work projects to improve the local fisheries. By joining our Club, you accept the risks and understand that fly-fishing on a stream or lake presents risk of serious injury and death by drowning, falling, hook injuries, injuries by tools and equipment, etc. Hand tools and machinery may be used on Club work projects. The terrain where the work project or the outing may occur may be irregular and difficult to navigate. No alcohol or drugs or any kind should be used while fly fishing, boating, or participating in a Club sponsored event. Club members assure the risk of injuries and death while participating in Club events. Club members expressly release the Club and waive their right to make claims or bring lawsuits against the Club while participating in Club outings and meetings. The liability for any accident, injury or death occurring during a Club meeting or outing falls on the member alone.
